Emergency and First Aid Procedure

Inhalation: Remove victim to fresh air; provide oxygen if breathing is difficult; administer CPR if victim is not breathing; seek medical attention. **Skin:** Remove contaminated clothing; flush with plenty of water for 15 minutes. launder contaminated clothing before reuse; if irritation persists, seek medical attention. **Eyes:** Flush eyes with water for 15 minutes while holding eyelids open; seek medical attention. **Ingestion:** Give two glasses of water for dilution; do not induce vomiting unless directed by medical personnel; never give anything by mouth to an unconscious person; seek medical attention.

Steps to be Taken in Case Material is Released or Spilled

Ventilate area and confine spill, soak up with non-combustible absorbent, shovel product into approved container; for spills in excess of allowable limits (RQ) notify the National Response Center (800) 424-8802; refer to SARA Title III, Section 313 40 CFR 372, and CERCLA 40 CFR 302 for complete regulations concerning reporting requirements.

Waste Disposal Method

Keep container closed when not in use; protect containers from abuse; protect from extreme temperatures.
